2020年2月10日葵青貨櫃碼頭全面實施入口貨櫃電子提櫃操作

葵青貨櫃碼頭 1 就早前推出的入口貨櫃提櫃操作數碼化計劃,已進一步宣佈實施時間 表。入口貨櫃電子提櫃措施將於 2020 年 2 月 10 日全面實行(請參閱 http://www.oneport.com/hkctoa/20191115.pdf) •

電子提櫃單 (eRO) 將取代現今的紙張 DO,eRO 由船公司通過一路通提供的 eRO 服務平 台向貨主/貨代發出,再經平台安全發放/轉送到相關生意夥伴。貨主在平台轉送給運輸 公司後,運輸公司只須在提櫃前在平台上指派提櫃車牌及司機,司機便可用手機程式 港口通電子提櫃單(HKiPort eRO)內的 eRO 二維碼 (QR code) 入閘提重。

為確保業界(包括貨運代理、貨主、運輸公司及相關代理)為碼頭全面實施的電子提重操 作,作充份準備,懇請各業界客戶能盡快完成登記 eRO 服務及開始熟習使用。

登記:請登入 reg.OnePort.com 登記服務。

開始使用:完成登記手續後,一路通將以電郵通知登入用戶資料。請登入 eRO 平台開始使用,使用簡介請參閱 http://www.oneport.com/ero/eroquickstart.pdf。

- I. 提醒你的客戶通過 eRO 平台轉送 eRO 給你
- II. 通知你的司機在 Apple Store 或 Google Play 下載 HKiPort eRO,以 便接收 eRO 二維碼 (QR code)。

現今,客戶可繼續免費使用 eRO 增值服務; 服務開始收費的時間及收費詳情,將會在 2020年1月份公佈。

The Time Has Come!

Kwai Tsing Terminals Set to Fully Implement Electronic Release of Import Containers on 10th February 2020

With regard to the digitization project for electronic release of import containers, Kwai Tsing container terminals ¹ further announced the timetable of full implementation which is set to take place on 10th of **February** 2020. electronic Release Order (eRO) is to replace the paper DO still being used in today's practice. On eRO platform developed by OnePort, an eRO is issued by the respective shipping line to the consignee/ the forwarder who further releases/ forwards the eRO to his business partner on the platform. After the consignee forwards the eRO to his trucking partner, the trucking company is only required to assign a tractor and a driver on eRO platform. For gate-in and pickup, the truck driver can just simply show the QR code displayed on the mobile app HKiPort eRO.

To ensure members of the port community - including forwarders, consignees, trucking companies and corresponding agents - make sufficient preparation for the full implementation of electronic release, we earnestly advise you to complete eRO registration asap and start using the service.

Registration: Sign up for eRO at <u>reg.OnePort.com</u>.

Quick Start: Upon completion of registration, OnePort will send out the login credentials by email. Please log into eRO platform and start using the service. For procedures on quick start, please visit http://www.oneport.com/ero/eroquickstart.pdf •

If you are a trucking company, please pay attention to the followings:

- Remind your customer to forward the eRO to you on eRO platform; and
- Notify your truck drivers to download the mobile app HKiPort eRO on II. Apple Store or Google Pay for the purpose of receiving QR code of eRO.

For now, eRO users can continue to use this value-added service of eRO for free. The timetable of charge and the future charge details will be announced in January 2020.
