eRO 電子提櫃單服務最新消息

入口貨櫃電子提櫃措施於 2019 年內全面實施

Wan Hai*、Hapag-Lloyd 及 KMTC 相繼率先於 3 月 11 日全面開放 eRO 服務給所有客户

現今一個入口貨櫃·由船到卸下至運輸提櫃離開碼頭·是經過多重繁覆的文件處理、傳遞及轉手·當中的過程產生不必要的延誤及資源虛耗。香港貨櫃碼頭商會(HKCTOA)於 2018 年 1 月宣佈葵青貨櫃碼頭 1 已決定於 2019 年內全面實施入口貨櫃提櫃操作電子化·透過一路通有限公司(一路通)提供的技術方案·為各業界客戶 2 (特別是船公司、貨運代理、貨主及運輸公司)·打開提升工作效率、節省營運成本的大門。而這措施亦獲船公司積極參與並大力支持·目前已有十多間船公司·為其特選客戶提供電子提櫃單(eRO)服務;在3月11日起,Wan Hai*、Hapag-Lloyd 及KMTC 相繼率先全面開放 eRO 服務給其所有客户使用,eRO 客戶在3月11日後可於 eRO 服務平台(eRO.OnePort.com)上,以電子形式處理 3 所有上述任何一間船公司的入口貨櫃提櫃事宜,往後階段全面開放的船公司名單(包括 CK Line、CMA CGM、Dong Young、Evergreen、Heung-A、Maersk、MSC、Namsung、ONE、RCL、Sealand、Sinokor、T.S. Lines、ZIM 等等)亦將稍後公佈。為協助客戶有足夠時間過渡至電子操作方式,我方熱切建議各客戶能盡快進行以下事項:

* 貴客戶開始用 Wan Hai 電子提櫃單服務前,請先聯絡一路通客戶服務部(電話:3669-1406),了解操作詳情。

1. 各業界客戶² 請盡早於 req.OnePort.com 登記 eRO 服務

如你的業務包括處理入口貨櫃‧請立刻登記。為鼓勵各業界客戶 2 (特別是貨運代理、貨主及運輸公司)盡早登記、培訓及試用‧一路通將為所有在 2 019 年 3 月 31 日前成功於 reg.OnePort.com 登記的新用戶‧提供 2019 年無限次免費使用 eRO 服務的優惠。



Electronic Release Order (eRO) service Latest News

Electronic Release for Import Containers to be Fully Implemented within 2019 With Wan Hai*, Hapag-Lloyd & KMTC Running up to Open eRO service to All Customers by 11/3

From being unloaded at dock to leaving the terminal, an import container today goes through a litany of time-consuming and inconvenient paper administration tasks – including document processing, physical delivery and title transfer - before being picked up by a truck driver at terminal. This process creates unnecessary time delays and undesirable wastage of resources. In January 2018, Hong Kong Container Terminal Operators Association (HKCTOA) announced that Kwai Tsing container terminals ¹ will fully implement electronic release for import containers in 2019 and have engaged OnePort Limited (OnePort) in the technical implementation. The implementation immensely opens a gateway to ultimate efficiency acceleration and cost saving for the port community 2 - particularly shipping lines, freight forwarders, consignees and trucking companies. As expected, it has been well received by shipping lines, currently with more than 10 liners offering Electronic Release Order (eRO) service to their selected customers. Moving to the next stage, Wan Hai*, Hapag-Lloyd & KMTC run up to open eRO service to all customers. By 11 March 2019, eRO customers are able to electronically handle ³ all import containers of the abovementioned shipping lines on eRO platform (eRO.OnePort.com). As for subsequent batches of liners (including CK Line, CMA CGM, Dong Young, Evergreen, Heung-A, Maersk, MSC, Namsung, ONE, RCL, Sealand, Sinokor, T.S. Lines, ZIM, etc), the schedule will be announced in due course. In order to allow sufficient time for transition to the new electronic practice, we strongly advise you to complete the following tasks:

1. Port community ² members to sign up for eRO service on reg.OnePort.com asap If your business involves handling of import containers, please sign up asap. As a token of appreciation to members of the port community ² in particular for freight forwarders, consignees and trucking companies, we are now offering free and unlimited use of eRO service in 2019 for those who sign up on reg.OnePort.com before 31 March 2019.

- 3. <u>Please forward this latest news to your freight forwarders, consignees & trucking companies</u> and remind them to sign up for eRO in order for you to experience a complete and uninterrupted service.
 - *** Note: There may be some cases in which consignees of the import containers are not involved in the daily handling of import release documents and, instead, entrust the tasks to you or other business partners. For the purpose of securing title ownership of their containers, those consignees are nevertheless required to sign up for eRO service before they can entrust an agent for further handling. ***
- 4. For Wan Hai, Hapag-Lloyd & KMTC customers who have already signed up for eRO, please log into eRO platform (eRO.OnePort.com) on or after 11 March 2019 and try to handle your import containers on eRO platform. For the announcement on subsequent batches of liners (including CK Line, CMA CGM, Dong Young, Evergreen, Heung-A, Maersk, MSC, Namsung, ONE, RCL, Sealand, Sinokor, T.S. Lines, ZIM, etc), please closely follow our updates.
